Terms of References:

1. Director will be overall *in-charge* of the Liver Transplant Program.
2. M.S. will look after the facility development progress and facilitate smooth procurement of consumables and drugs related to Liver Transplant.
3. Dr. Utpal Anand will develop in association with Gastroenterology department, the transplant program, services related all form of liver transplant therapy in view of holistic management of the CLD patients. He will be responsible for the creation of waiting list pool of the prospective liver recipient.
4. Dr. Ramesh Kumar will stabilise CLD patients on waiting list for Liver Transplant and also responsible for perioperative & postoperative management of transplant patients along-with ICU & surgical team.
5. Dr. Amit Patil will provide timely services whenever required most importantly in deceased organ donation, along with medico-legal aspect related to Liver Transplant.
6. Dr. Kunal Singh will develop the LTU with all the necessary equipment. He will also look after the development of OT services for the Liver donation and recipient surgeries.
7. Dr. Rajeev Nayan Priyadarshi, will facilitate the arrangement of timely radiological services on 24x7 required for the liver recipient and donors. A Doppler machine has to be made available 24x7 in LTU.

Dr. Mala Mahato will be responsible for 24x7 Clinical Biochemistry services on priority basis for liver transplant patients, both donor and recipient, she will take care of the necessary arrangement required for the service, also will look to have all Clinical Biochemistry services available at AIIMS Patna in long-term.
9. Dr. Surabhi will make an arrangement for the timely availability of services for the Liver Transplant patients on priority, she will also ensure self-dependency of all Pathology services for the Liver Transplant Patients on priority, and she will also ensure self-dependency of all Pathology services for the Liver Transplant patient at the Institute only, in long-term.
10. Dr. Bhaskar Thakuria will look after the Microbiology services related to transplant patients on priority and in timely manner. He will also make the Institute self-dependent in long term for all Microbiology services related to the Liver Transplant patients.
11. Dr. Mala Mahato will facilitate the establishment of immunology lab at AIIMS Patna with latest available technology, so that for any immunological services, the dependency on outsourcing can be stopped in long term.
12. Dr. Utpal Anand will ensure the establishment of Liver Transplant Unit at AIIMS Patna & smooth functioning of the program and facilitate the program to start at the earliest. He will call timely meetings of the Committee in consultation with the Executive Director and Medical Superintendent apart from making necessary arrangement for the Liver Transplant Surgery to happen.
